#### Introduction to EXCEL Accelerator

EXCEL Accelerator is the flagship program of the Energy Internet Innovation and Entrepreneurship Center (EIIEC) jointly organized by Sichuan Energy Internet Research Institute, Tsinghua University(EIRI), Chengdu Sci-tech Innovation Service Center of Tianfu New Area and New Energy Nexus.

EXCEL Accelerator is recruiting growth stage startups worldwide in both climate and energy with an emphasis on heavy industry and utilities.

EXCEL Accelerator will provide capacity building, technology workshops and market consultation over the course of six months.

#### **General Questions**

#### 1. What is the role of Energy Internet Innovation and Entrepreneurship Center (EIIEC) ?

EIIEC is the sponsor and host of EXCEL Accelerator.

EllEC is an innovation hub focusing on the development of the energy industry. Co-founded by the Sichuan Energy Internet Research Institute under Tsinghua University, New Energy Nexus (the United States) and the Chengdu Sci-tech Innovation Service Center of Tianfu New Area, it features professional industrial support, energy innovation accelerator and industrial resources integration and is committed to building an international think tank and an in-and-out window.

#### 2. How many startups will be accepted to EXCEL Accelerator 2020?

A maximum of 20 startups will be selected.

We will invite heads of industrial companies, industry experts from Tsinghua University and heads of innovation organizations to form a jury and impartially select startups based on resume, technical competence and interview.

#### 3. Fees related to the EXCEL Accelerator

Activities and training for startups of the EXCEL Accelerator are free of charge for cohort startups (Travel fee excluded). Appropriate fees will be charged for customized services.

#### **Application Details**

#### 1. My company is registered outside of China. Am I qualified to apply for the accelerator?

EXCEL Accelerator is open to both Chinese companies and growth stage startups around the world.

#### 2. Are companies that have not yet entered the prototype stage qualified to apply?

We sincerely welcome the application from all companies with original technologies and products and wish to bring optimal value to the companies. It is possible that your application will be approved, but you are recommended to reach the prototype stage so that we can work out a more proper acceleration plan for you.

#### 3. May I submit additional files to support my application?

Evaluation will be based on the completion of the Submittable application form. If you have specific requests for the EXCEL Accelerator or EIIEC, please contact <u>eliec@eliec.com.cn</u> and we will contact you as soon as possible.

#### 4. Do I need to attend all activities during the accelerator?

In principle, all cohort startups will be required to attend the open day, mid-term roadshow and Demo Day (offline or online). Startups may selectively attend industrial activities and training courses according to location and schedule during the 6-month time.

#### 5. Will EXCEL Accelerator serve competing companies?

EXCEL Accelerator will do its best to avoid accepting competing startups to the same cohort. In the case of competing startups in the same cohort, unremitting efforts will be made to ensure no sensitive data will be exchanged.

#### 6. How will EXCEL Accelerator protect the intellectual property rights of cohort startups?
