- Research & identify relevant professionals for activities, including trainers, facilitators, business advisors, designers etc.

- Support marketing & social media activities: invitations, outreach, media and administrative preparation
- Support in managing the engagement of startups in the accelerator programs and provide support needed to help companies succeed with their goals.

The position will be \sim 30 hours a week and based in Singapore (Other locations in ASEAN possible). Duration is a **minimum of 3 months** with possibility of extension. The position is unpaid, but a monthly stipend will be provided to the selected candidate.
